

- 1 Classes:-
 - a) Playing Member
 - b) Junior Member (under 18 years of age on 1st May)
 - c) Social (Non Playing)
 - d) Enhanced Social (Play allowed on carpet green only)
 - e) Temporary
 - f) Day
 - g) Life Member

Social (none playing), temporary and day members may not vote at any General Meeting of the Club.
After membership in classes A, B, or C has been granted it is considered continuous from year to year on payment of the relative annual subscription.
- 2 New members, after they have been advised that their application for membership has been granted, must satisfy the Club Coaches that they are competent to bowl correctly before they may use the grass green unsupervised.
- 3 Temporary membership for the day is extended to members of visiting teams and individuals playing in organised competitions. Temporary membership may also be extended for a period of up to one month to persons visiting the area who are bona fide members of a Bowling Club on payment of a fee which shall be determined by the Management Committee. Temporary membership confers only the right to play and use the facilities of the Club premises. It does not confer other rights of membership.
- 4 Members of the club in Classes a, c, d or g (as defined in Rule 1) may introduce non-member visitors into the club. These visitors shall receive Day Membership, excepting that a Day Member may not attend the club on more than four days in any one year and must pay on each occasion any fee or charge due for the activity or event. The names of Day Members must be entered into the visitor's book on each occasion and be counter-signed by the introducing Member. Day Membership does not confer other rights of membership and all entitlement is at the discretion of the Management Committee.
- 5 The Management Committee may terminate the membership of any member at any time on a resolution passed by a majority of at least two-thirds of the membership of the Management Committee.
- 6 The Management Committee may suspend the membership of a member for a fixed or indeterminate period on a resolution passed by a majority of at least two-thirds of the full membership of the Committee. If suspension is due to non payment of fees or subscriptions it shall be terminated on payment of the outstanding amount.
- 7 A member wishing to withdraw from the Club should give notice in writing to the Secretary of the Management Committee.
- 8 In the event of termination of membership the Management Committee shall have the power to reimburse all or part of fees or subscriptions paid.
- 9 Any person whose membership has been terminated or suspended by the Management Committee may not enter the Club premises without the prior approval of the Management Committee.
- 10 Subscriptions/Fees.

The Annual General Meeting shall decide the level payable by members. No Member may use the Club's facilities until the appropriate subscription has been paid.
The Management Committee shall have power to charge a reduced subscription for the current year to a member joining after the beginning of the season.
Subscriptions and fees for existing members are due and payable by **1st March**.
- 11 Bowling.

Play shall be conducted in accordance with the Laws of the World Bowls Board and the Rules of Bowls England and Local Rules as agreed by the Management Committee. The etiquette of the game shall be observed and dress worn when playing shall conform to the standard laid down by the Management Committee. It is a condition of membership that playing members familiarise themselves with the Laws and Etiquette of the game.
- 12 Complaints
Complaints, whether about the facilities or other members or servants of the Club, must be made in writing to the Club Secretary or a Club Welfare Officer. Under no circumstances shall complaints be made to servants of the Club except through the Management Committee.
- 13 Neither the Club its Officers nor the Committee shall accept responsibility for loss or damage incurred on the Club's premises.
- 14 No alterations shall be made to these Rules except at a Management Committee Meeting called for that purpose.
